Open House Check Sheet

Pre-Planning

| [] Make sure you have communicated to your seller in regards of timing |

| [] Notify your front desk you are having an open house |
| [] Update your MLS of the open house (as far ahead as possible) |
| [] Contact your lending partner to join you, Cal Coast is most always accessible |
| (request the front desk to send out a request to Cal Coast Agents if needed) |
| [] Announcement to neighborhood/community (emails, mail, cold calling) |
| [] Announce through your social media & Intero FB (Facebook, twitter, etc.) |
| [] Prepare professional & clean flier (Intero360), have printed (color fliers) |
| Print enough for door knocking prior if applicable |
| [] Bring your Open House Register (obtain free from the front desk) |
| [] Bring refreshments (cookies or anything with crumbs not suggested) |
| [] Bring Music |
| [] Bring Misc. items; (a) Please remove shoes sign, (b) booties |
| [] Make sure you know city guidelines for open houses, make sure you have enough signs, |
| you will have to borrow from either your office manager or another agent if you are in need |
| Day of Open House |
| [] Put out open house signs as early as possible, hit major corners (as many signs as possible) |
| [] Put up a rider on your yard sign that states "Saturday 1-4" or "Sunday 1-4" |
| [] Go door knocking with your lending partner prior to open house |
| [] Make sure you start setting up in the house 30-45 minutes prior to start time |
| [] During open house talk to & have people register as much as possible, WORK THE ROOM! |
| [] Update seller with how things went & results (if you call, follow up as well with email) |
| [] Within 24 hours add registry to your CRM, initiate your "Open House Drip Campaign" & And follow up when applicable |

10 Tips for a Successful OpenHouse

TIP: Schedule several back-to-back open houses on a given day. Schedule some weekdays.

Customers who frequently transfer may consider house hunting work and may prefer to do it during the week. —

- Don't be a chatterbox. Greet your visitors, give them your card and a property brochure, and allow them peace and quiet while they tour the home.
- 2.Be honest about the home's features and improvements. A seven-year-old roof isn't "new," although the owner may describe it as such. Many owners think any improvement they paid for themselves is "new," even if it was made more than a decade ago.
- 3.Don't drop vague hints about offers having been received for the home if that's not the case.
 When the truth later comes out, the buyers may feel manipulated and back out of the whole transaction.
- 4. Make copies of presale home and termite inspection reports available to prospective buyers along with estimates of the costs for any needed repairs or fumigation.
- 5.Display photographs of popular neighborhood amenities (e.g., local parks and recreation center).
- 6. Have comparable sales data available.
- 7. Give visitors property information sheets with important facts about the home and the community. Examples include a flyer highlighting the home's features, summaries of room size, lot size, taxes, and assessments; and a map showing the location of schools, hospitals, public transportation, libraries, supermarkets and other services and retailers.
- 8.Ask visitors for immediate feedback about the home. Also, <u>use a guest book</u> to collect visitors' names, telephone numbers, and e-mail addresses. Follow-up with a telephone call or e-mail after the event.
- Don't forget to turn off the lights, close the drapes, remove the guest book and brochures, and lock up before you leave.
- 10.Provide visitors with information about the property, floorplans, views and anything else pertinent or unique about the home. This way they can review what they've seen and not just rely on memory.
